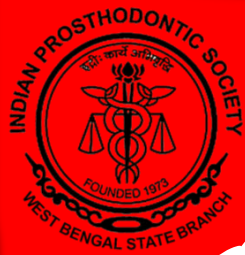

Even after all this we still don't know with certainty if the smart deadly virus has entered our environment or not.

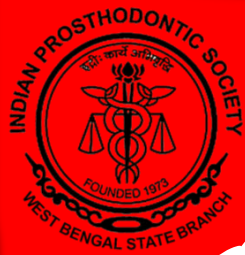
However, here I would like to draw your attention to some of the **opportunities** The COVID-19 pandemic presents for the Prosthodontists. The pandemic offers an opportunity for the Prosthodontists to shift more toward nonaerosolizing, prevention-centric approaches to care and away from Prosthodontic surgical interventions. Various changes to oral health care access suggested by our Council during the pandemic also could have a favourable impact if sustained into the future.

Prevention is the foundation of public health. The COVID-19 pandemic presents an opportunity for the Prosthodontists and dentists to shift from an approach focused on surgical intervention to one emphasizing prevention.

### **Prevention of Infection**

As a response to the evolving information about the novel coronavirus that causes COVID-19, health regulatory bodies across the world have worked to update their guidance for personal protective equipment (PPE) and infection prevention among healthcare workers and the general public. In the field of dentistry, PPE and disinfection of clinics and hospitals have long been a part of our practice of universal precautions. We Prosthodontists must continue to use PPE that is aligned with guidelines from the Council /association even after the pandemic is over. COVID-19 pandemic serves to heighten the awareness of dental aerosolization, pushing us to revisit the safety standards, improve compliance, and innovate new ways to safely deliver care to the patient.





# GUEST Editorial



## Tele-Prosthodontics

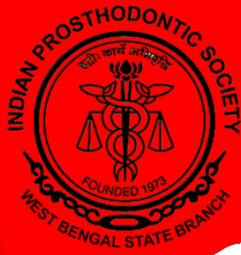
Telemedicine has gained popularity in recent years, allowing doctors and physicians to assess, educate, and provide therapy remotely through videoconferencing and other modalities. Tele dentistry/ tele-Prosthodontics has been adopted more slowly and on a smaller scale, as we are traditionally reimbursed for performing procedures rather than educating patients and triaging remotely.

One positive that has resulted from the current pandemic is that many clinics and hospitals have responded favorably to tele Dentistry & Prosthodontics, allowing us to continue to stay connected to our patients. This has opened the doors for interprofessional collaborative care opportunities, such as treating home-bound or facility-bound patients, patients who live in rural areas, and other patients who have difficulty accessing Prosthodontic and overall oral health care.

## Social factors of Prosthodontic care

While the primary focus of Prosthodontics continues to be procedures, we have also evolved to become better aware of systemic medical conditions and social factors that impact the safe delivery of Prosthodontic care.

Over the decades, our patients have become increasingly diverse in ethnicity, socioeconomic background, and medical complexity. This pandemic has reminded us that these factors play a large role in the ability to access, obtain, and receive high-quality health care. As we think about oral health and re-opening clinics, we must keep in mind that patients will have varying medical risk factors that affect their susceptibility to aerosolized microorganisms. Moreover, the increasing unemployment rate will impact patients' ability to continue affording Prosthodontic care. One of the benefits of this pandemic is that we will have the opportunity to more systematically incorporate medical and social factors into our Prosthodontic delivery models.

## Digital Technology

This pandemic has forced us to learn the use of videoconferencing very quickly, not only for the education we are delivering to our students, but for overseeing the education our school-aged children are now doing at home. Additionally, Prosthodontic and dental education conferences are sometimes inaccessible to some practitioners, faculty and students because of cost or other reasons preventing them from traveling. Since we have all become more comfortable with videoconferencing capabilities, this opens up an opportunity to have substantially higher participation in these meetings and conferences, making the generated new knowledge available to more people.

## Cooperation and Compassion

This pandemic has reminded us that we are all human first, we are vulnerable, and we can support each other in times of need. In a time in our history when our differences have been so greatly emphasized, this pandemic has allowed us to give and receive compassion and remember our similarities and common goals. 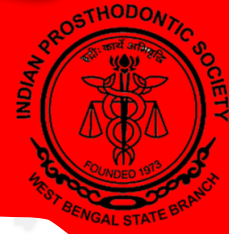

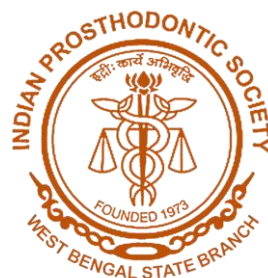
Contributions can be in the form of snippets, case reports, clinical experiences, practice management tips, recent trends, and other useful information from all walks of life.
